Salem Hospital PGY1 Residency Learning Experiences

Rotational Experiences are generally 4 weeks in length. Some rotations may be longer or shorter based on resident schedule / preceptor availability. Most experiences may be repeated as an elective but no more than 12 weeks can be spent in a single level of care (i.e. Critical Care, Internal Medicine).

Core (Required) Rotations

- Antimicrobial Stewardship
- Cardiovascular Intensive Care / Cardiology
- Emergency Department
- Internal Medicine I & II
- Intensive Care I & II
- IV Room (2 weeks)
- Pharmacy Informatics

Elective Rotations

- Emergency Department II
- Neonatal Intensive Care
- Oncology (Adult)
- Operating Room (2 weeks)
- Inpatient Psychiatry (off-site, requires prior approval)

Longitudinal Experiences are longer in duration and may span a few months or last the entire year.

Additional Details:

Citywide Residency Conference: *Bimonthly meetings with participation requirement, intended to round out a residency experience and provide networking opportunities with Portland-area residents & RPDs.*

Residency Research Project: *Each resident completes a research project during the residency year. Projects are selected by the resident and approved by the program director early in the year. Residents develop a time line, receive IRB approval and submit an abstract (in early February) for presentation of the project at the Northwestern States Conference for Residents and Preceptors in May. Posters for ASHP Midyear are required.*

Oregon Pharmacy Teaching Certificate (OPTC) program: *didactic teaching course offered through the Citywide Residency Program with teaching experience gained at a local college or university. Application required.*

Evaluation and Assessment:

In addition to being evaluated by their preceptors, residents have the opportunity to be an active participant in their learning with self-evaluations and evaluation of each preceptor and learning experience. Evaluations occur at the end of every rotation, and at least quarterly for longitudinal rotations.
