Marita G. Titler, PhD, RN, FAAN Nurse Scholar

Dr. Titler is an internationally recognized nurse scholar and leader who has revolutionized patient care. An expert in health-services research, translation science, and evidence-based practice. She finished her doctoral degree in 1992 and established herself as a highly regarded nurse-scientist with an impressive body of research focused on outcomes effectiveness and implementation science to improve care of older adults. A cutting-edge researcher, she focuses her work on bettering patient care in hospital settings and has garnered more than \$170 million in external support. In addition, she has more than 300 publications to her credit, and has also contributed to more than 40 national evidence-based guidelines for care in areas such as acute confusion and delirium. Dr. Titler is the first author of the *Iowa Model of Evidence-Based Practice to Improve Quality of Care*, which has been widely disseminated throughout the world.
