Salem Health epwe fiti ngeni met an ekkewe mei osupwangen senis re eucheani me angang non pwung me wenewen non ar emwekut, anisi meinsin mei semwmwen non ar awora sufon, mennin, me tong.

Chon angangen Revenue Cycle repwe anganga ar repwe feriochu fatanin moni epwe naff ngeni an ekkewe mei semwmwen niwinimang ren ar repwe pwan ioni kewe niwinimang seni mei semwmwen, kewe ekkoch insurance, me kewe niwinimang an kewe ese wor neur insurance ika ar niwinimangen akkomw iwe awora ototen kametiwan, inet re eucheani an epwe kawor, me esapw wata won kewe mei semwmwen osukosukan.

Salem Health mi awora sokkopaten aninnis epwe tongeni anisi kewe mei semwmwen ren an repwe awesi ar niwinimang, pachonong ar pwan katon ika kewe mei semwmwen iir mei tongeni neunew kewe pekinn aninnis, monien aninnis, me pwan ekkoch sokkun koturun meme, me attamano fansoun meni niwinimang. Kewe mei semwmwen iir mei wanong neur apinikeison me a fat me kukkun seni 400% ar osupwang (federal poverty level) iwe iir mei tongeni neunew ei pekinn aninnis. Katon tichikin porousen non na kinikinin e porousen ennu. Salem Health epwe katon kewe mei semwmwen re nomw Oregon ika io ese wor neun insurance (public ika private), ese nifinifin mei semwmwen ir mei nomw fan aninnisi seni ewe state medical assistance program, ika ese nifinifin mei semwmwen io mei wor an niwinimang ngeni pioing seni \$500 nimepwuku chana ika nap seni non echo neun taropwen niwinimang, me mwen epwe angei neun (statement). Salem Health epwe pwan katon meinisin mei semwmwen re nomw Oregon me mwen epwe tiini ngeni ewe nenien ioi niwinimang.

Presumptive charity discounts (ew sokkun aninnis) e nongonong won Federal Poverty Guidelines (FPG) ar repwe fini io epwe neunew me (kei ruw ennu) Oregon House Bill 3076 me ewe Oregon House Bill 3320. Ei pekin aninnis epwe akkatona an emon me emon tongeni epwe neunew ren an epwe nennengeni:

- (a) An ewe mei semwmwen (record) nonnomwun ika porousen mei wor;
- (b) Porous epwe ikkioi fansoun an ewe mei semwmwen makei itan me nuwiing non pioing;
- (c) Porous ewe mei semwmwen epwe pwusin finata an epwe awora;
- (d) Met kewe ekkesiwin mei fer non kewe aninnisin moni; me
- (e) Kewe pwopwun mei wor ren kewe (program) ren pekin aninnis. Awewe mei pachonong, nge esapw keuk me won: Medicaid, Supplemental Nutrition Assistance Program (SNAP), Temporary Assistance for Needy Families (TANF), Women, Infants and Children (WIC), (program) ren mongon nesossor me nonowas ese kame, low income home energy assistance programs, ika ese nifinifin sokkun (program) mei wor ren ar repwe tongeni tafa me arere ren an chochon ewe iimw moni tonong.

Salem Health epwe wanong non mak/taropwe pwun ewe mei semwmwen mei angeni ewe (presumptive eligibility discount), me ewe sewmwun e finata an esapw etiwa.
